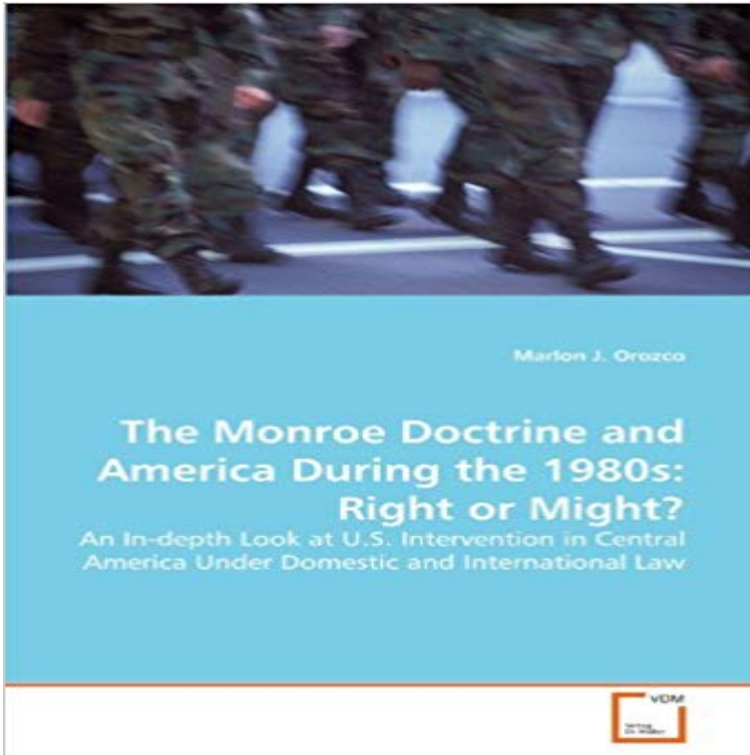


## The Monroe Doctrine and America During the 1980s: Right or Might?: An In-depth Look at U.S. Intervention in Central America Under Domestic and International Law
