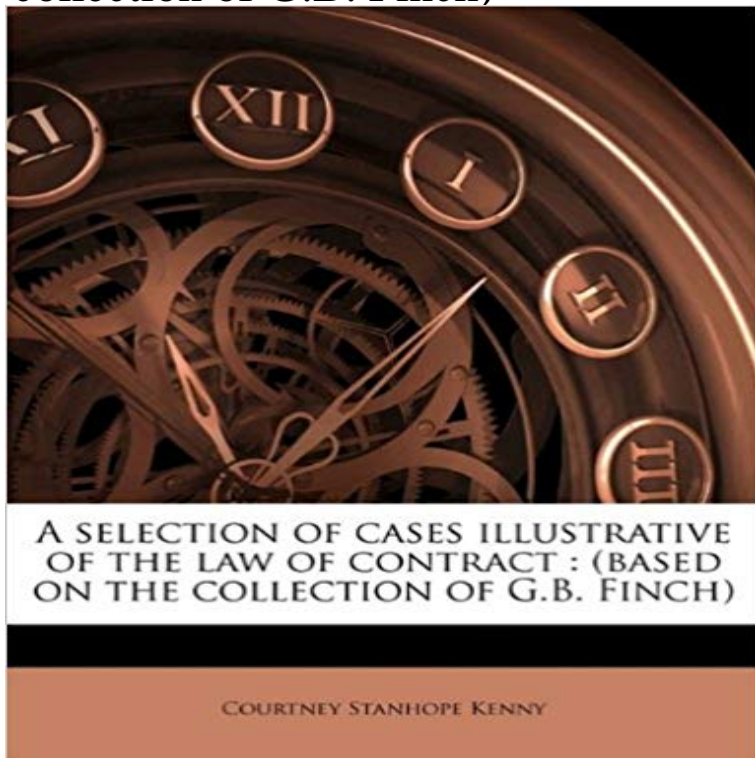


A selection of cases illustrative of the law of contract: (based on the collection of G.B. Finch)
