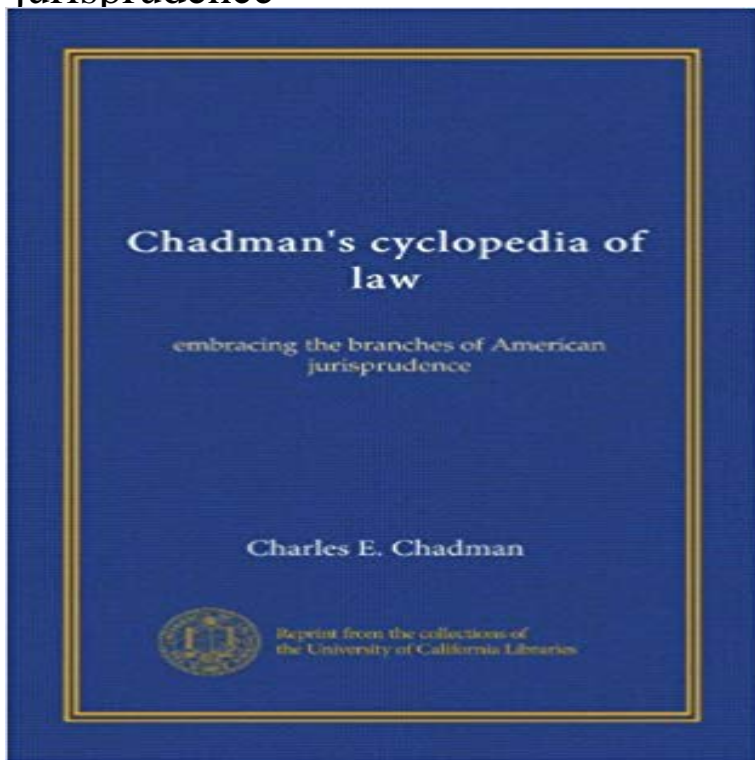


## Chadmans cyclopedia of law (v.07): embracing the branches of American jurisprudence
