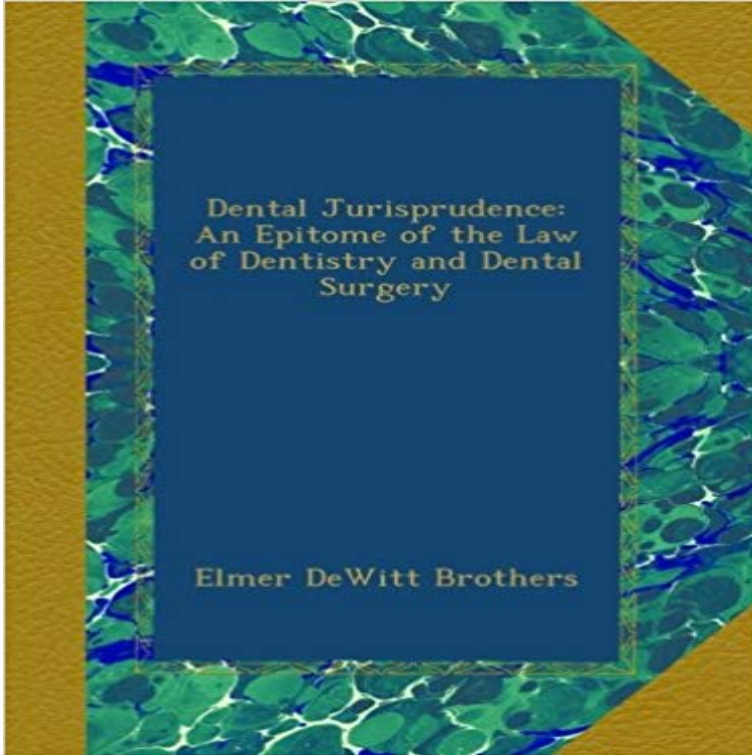


# Dental Jurisprudence: An Epitome of the Law of Dentistry and Dental Surgery
