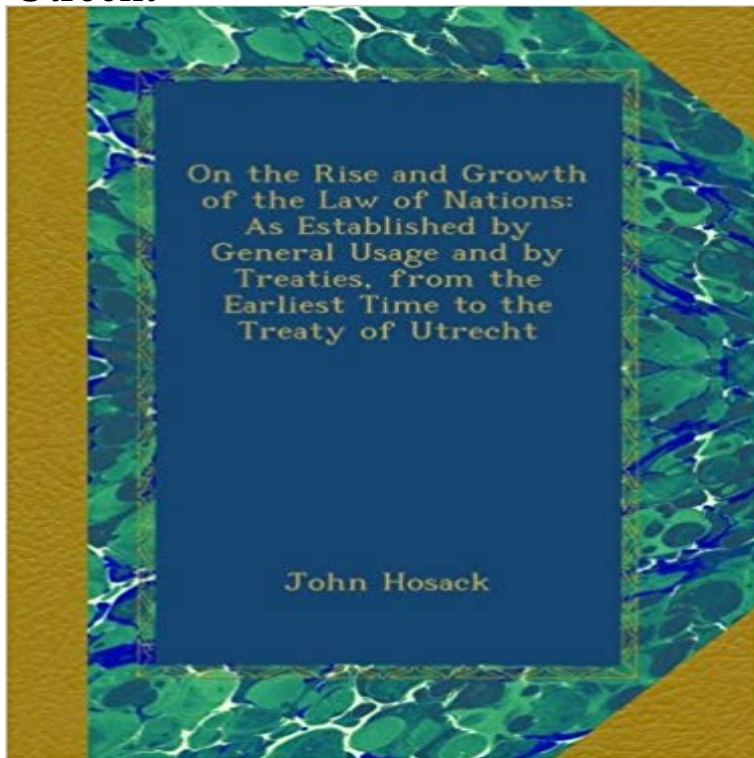


On the Rise and Growth of the Law of Nations: As Established by General Usage and by Treaties, from the Earliest Time to the Treaty of Utrecht
