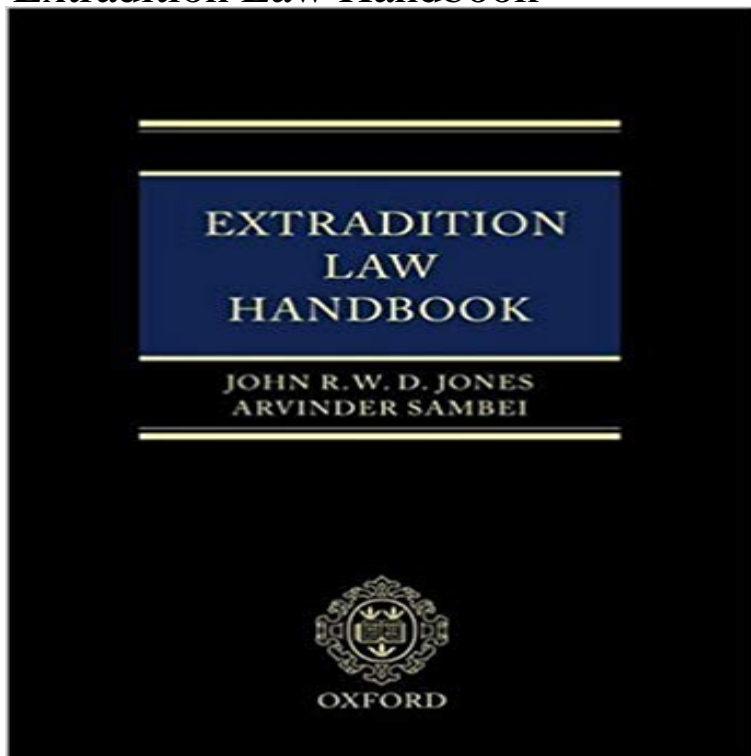


# Extradition Law Handbook

The Extradition Act 2003 came into force on 1 January 2004, and the Handbook covers the provisions of the 1989 Act and the new Act as the transitional provisions still apply to existing extradition proceedings. Sections on Human Rights implications and war crimes tribunals are also included, as well as useful appendix materials.
