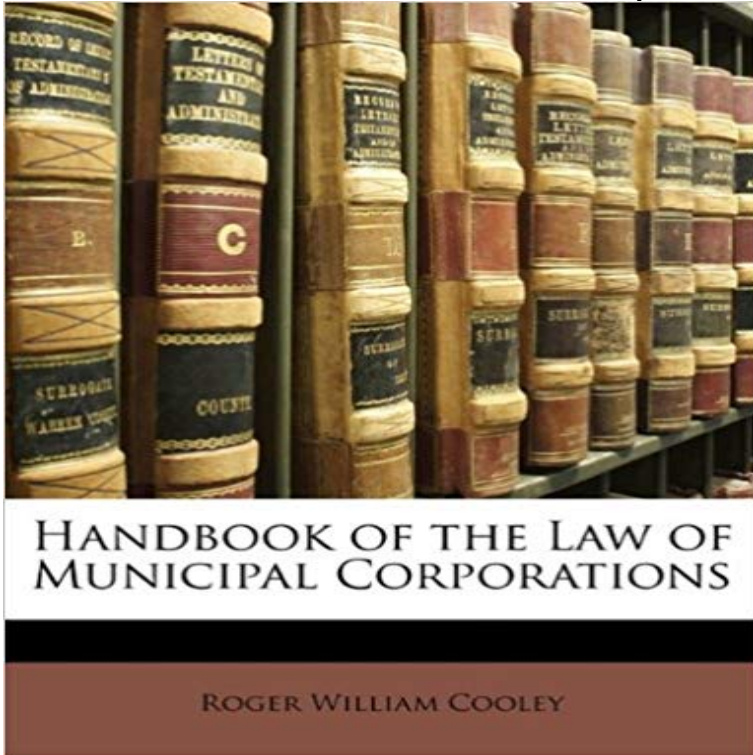


Handbook of the Law of Municipal Corporations
