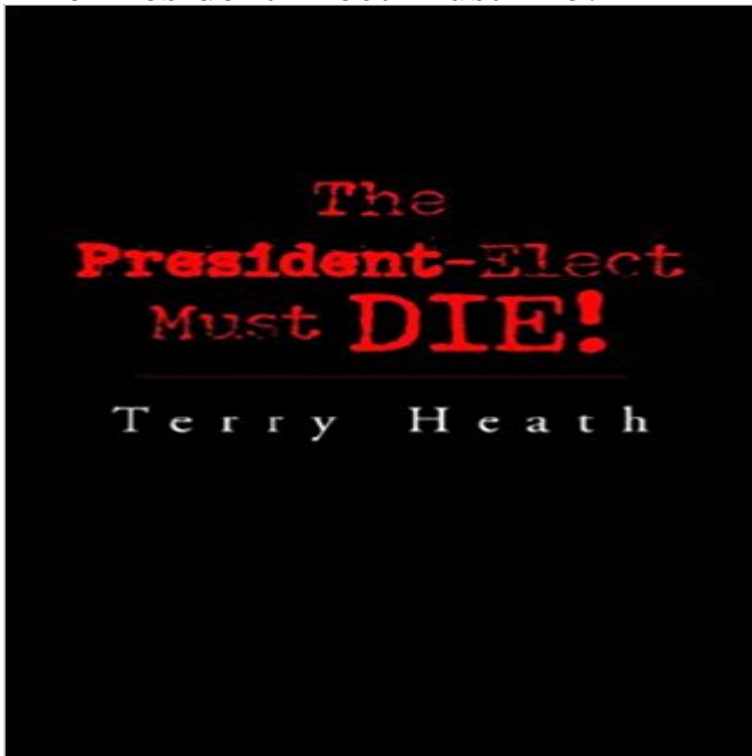


The President-Elect Must Die!
