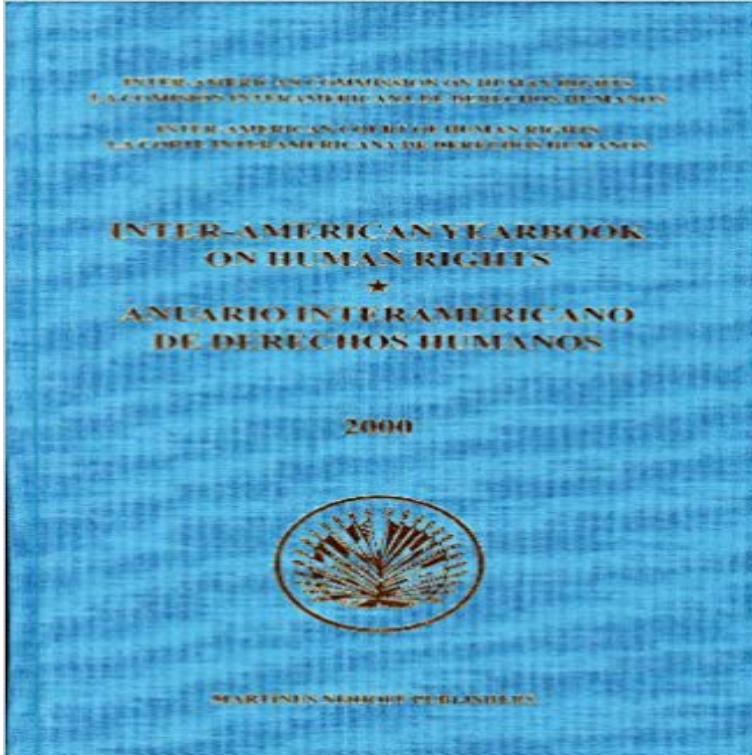


Inter-American Yearbook On Human Rights 2000, Vol. 16 (Anuario Interamericano de D) (2 Volume Set) (v. 16)
