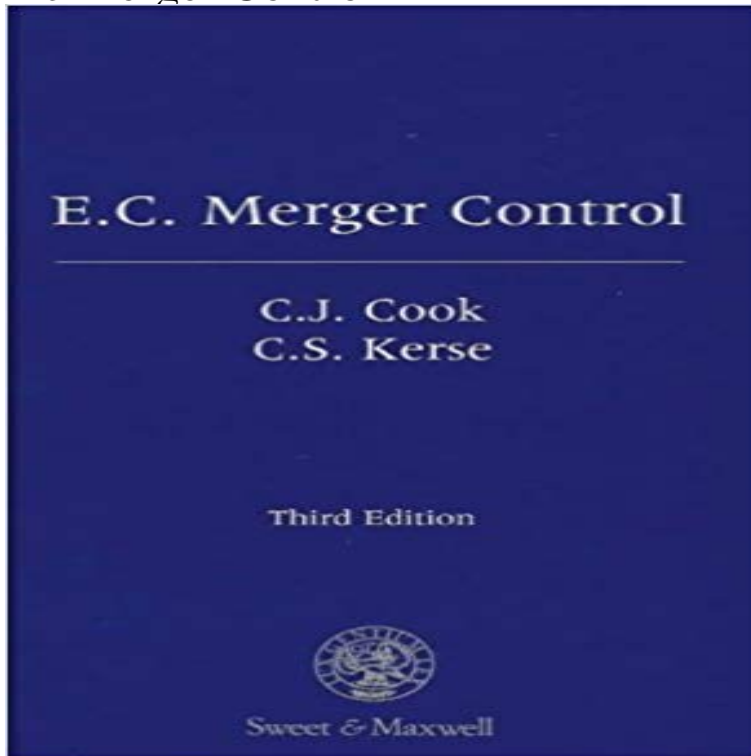


Ec Merger Control
