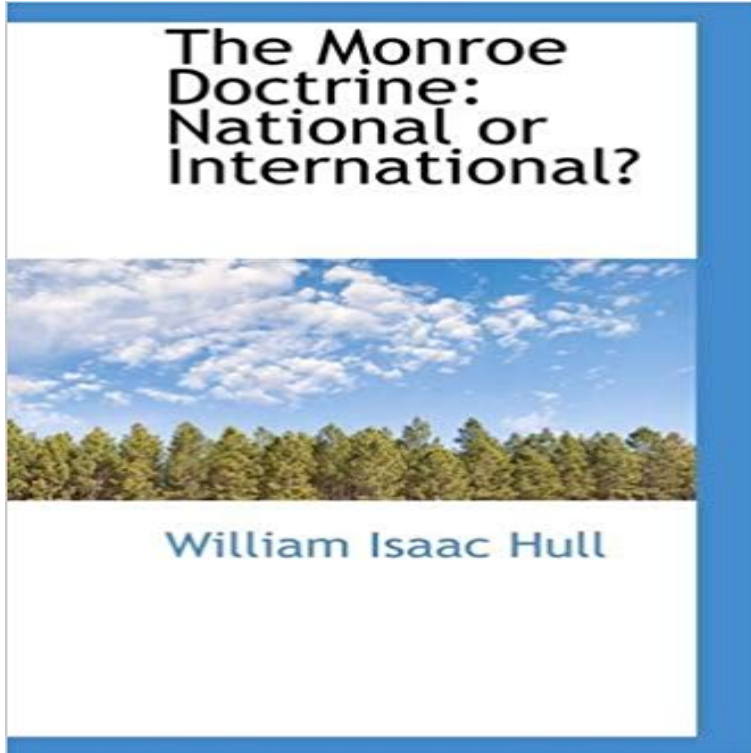


## The Monroe Doctrine: National or International?
