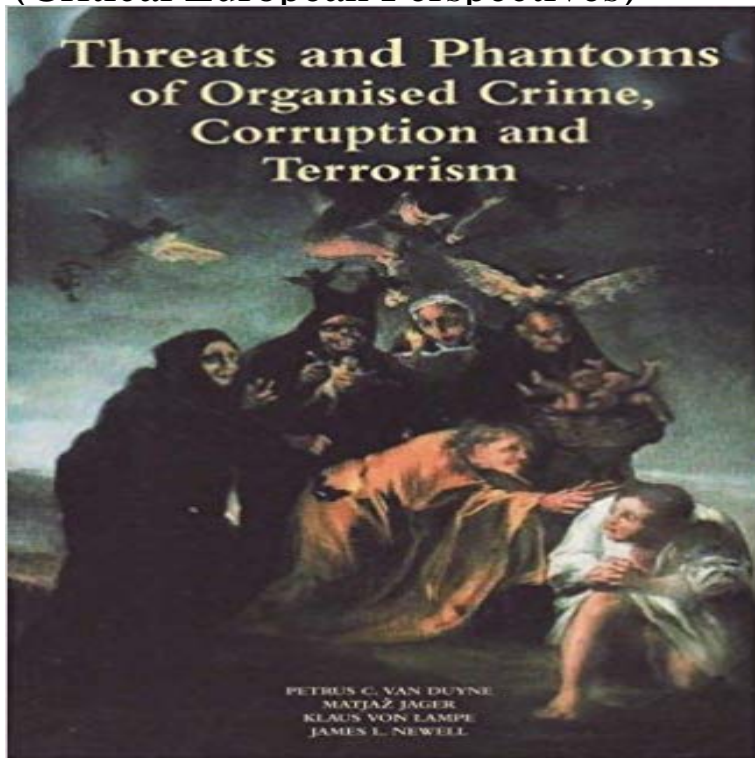


Threats and Phantoms of Organised Crime, Corruption and Terrorism (Critical European Perspectives)
