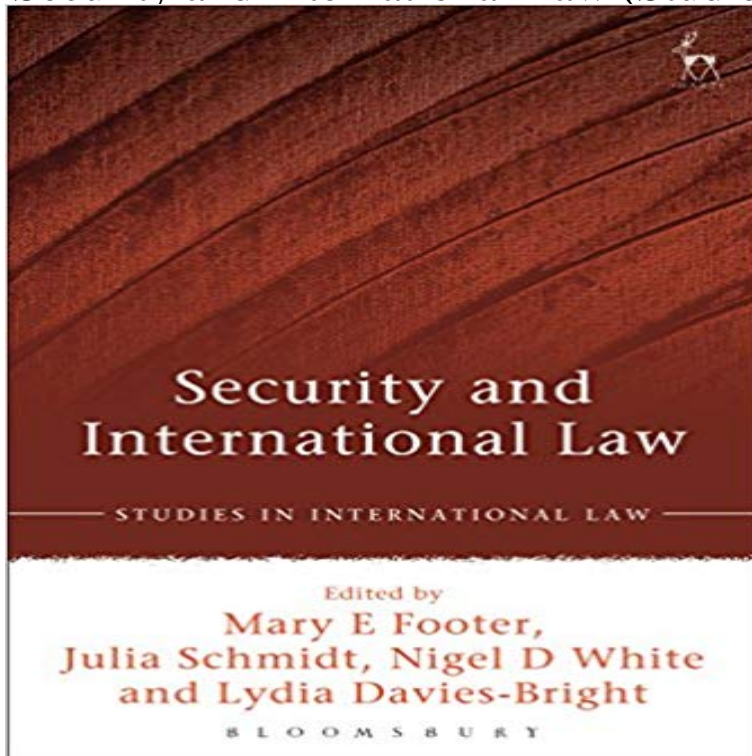


## Security and International Law (Studies in International Law)
